**ORDER ON JOINT
MOTION TO MAKE COURT RECORDS CONFIDENTIAL**


THIS CAUSE came to be heard by the Court on the Parties' Joint Motion to Make Court Records Confidential, and the Court having reviewed the Parties' stipulation and being otherwise fully advised on the premises, it is therefore **ORDERED AND ADJUDGED**:

1. The Parties' Joint Motion to Make Court Records Confidential is hereby **GRANTED**;
2. The type of case in which the order is being entered is domestic relations;
3. The basis pursuant to 2.420(c)(9)(A) is the right to privacy of medical information;
4. The Parties' names are not to be made confidential;
5. The progress docket is not to be made confidential;
6. The particular court record is described as Orange county case-number 2008-DR-010663 styled as *Lewis v. Lewis*.
7. The Parties, Petitioner, Reynaldo Lewis, and Respondent, Kirsten A. Lewis and their present counsel, Carlton Pierce, Esquire, and M. Jesusa Cruz Pantón,

Esquire, are permitted to view the confidential records;

8. The Court finds that the degree, duration, and manner of confidentiality ordered is no broader than necessary to protect the interests set forth in subdivision 2.420(c)(9)(A) and no less restrictive measures are available to protect the interest set forth in 2.420(c)(9)(A);
9. The clerk of court is directed to publish this Order in accordance with 2.420(d)(4);
10. The Court retains jurisdiction for enforcement purposes and the entry of any other Orders as may be necessary to effectuate this Order's intent.
